PRIVACY COLLECTION STATEMENT**

**Updated 2 February 2015**

**1. Why we collect your personal information**

Pearson Australia Group Pty Ltd ABN 40 004 245 943 (through its Pearson Clinical and Talent Assessment division) (“we”, “us” or “our”) collects your personal information to: (i) administer and score the tests or assessments undertaken by you through our product platforms; and (ii) to provide the test or assessment results to the qualified clinician, professional, clinic or institution that administered the tests or assessments to you and that has an agreement with us to use the product platform for the administration, scoring or reporting of the tests or assessments (“**Qualified Customers**”).

**2. Consequences of not providing your personal information**

If you do not provide us with all or some of the personal information that we request, we may not be able to provide you with our products or services or you may not be able to use our products or services. That is, you may not be able to undertake any test or assessment on or through the Q-interactive platform.

**3. How we disclose your personal information**

We may disclose your personal information to other members of the Pearson plc group of companies located in other countries including the United States of America, Canada, the United Kingdom, Singapore, Hong Kong, the Ukraine and China.

We may also disclose your personal information, and you consent to us disclosing your personal information, to third parties:

- that are the Qualified Customers who administered or assigned the relevant test or assessment to you;
- engaged by us to perform functions or provide products or services on our behalf, such as processing of credit card information, mailouts, debt collection, marketing, research, advertising or hosting of customer relationship management (CRM) systems. Such third parties include Rocket Science Group LLC (including MailChimp), SurveyMonkey Inc (including Wufoo) and Salesforce;
- that are our agents, business partners or joint venture entities or partners;
- that sponsor or promote any competition that we conduct or promote via our services;
- authorised by you to receive information held by us;
- as part of any investigation in relation to you or your activity which we suspect to be a breach of any of our terms and conditions or any agreement between you and us, serious misconduct or unlawful (including disclosure to the police, any relevant authority or enforcement body, or your Internet Service Provider or network administrator);
- that are our external advisers or potential or actual bidders or their external advisers as part of a sale or proposed sale of all or part of our business; and/or
- as required or permitted by any law or regulation (including the Privacy Act).

Some of these third parties to which we may disclose your personal information may be located in other countries including United States of America, Canada, the United Kingdom, Singapore, Hong Kong, the Ukraine, China and Luxembourg.

In the event that you wish to use our products or services (including undertake any test or assessment) on or through our other platforms or other platforms of other members of the Pearson plc group of companies, those other platforms may permit the migration of your personal information stored on or through Pearson Clinical and Talent Assessment platform in Australia (or elsewhere in accordance with this document) to those other platforms. You hereby consent to such migration.

We hereby expressly inform you that if you consent to the disclosure of personal information about you by us to a third party who is not in Australia or an external Territory, subclause 8.1 of the *Privacy Act 1988* (Cth) will not apply to the disclosure. After being so informed, you consent to the disclosure by: (i) undertaking any test or assessment through a Pearson controlled platform; or (ii) confirming that consent to the Qualified Customer for the benefit of Pearson.
